## 4. FIRST AID MEASURES

Eye contact: Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally

lifting the upper and lower eyelids. Get medical attention if symptoms occur.

**Skin contact:** In case of contact, flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.

## 6. ACCIDENTAL RELEASE MEASURES

## 7. HANDLING AND STORAGE

**Handling:** Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapor or mist.

Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain

product residue and can be hazardous. Do not reuse container.

Storage: Store in accordance with local regulations. Store in a segregated and approved area. Store in original

container, protected from direct sunlight. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage.
