## Section II - Hazards Identification

Danger: Causes severe skin burns and eye damage. Wash thoroughly after handling. Wear protective clothing, eye and face protection. If swallowed, rinse mouth with water but do not induce vomiting. #### **Potential Health Effects**

Trichloroacetic acid is a strong acid that will cause tissue damage and severe ulcers on contact with skin or eyes. *Inhalation:* Extremely corrosive to mucous membranes and other structures in the respiratory tract. Will cause pulmonary edema.

Ingestion: Can cause severe burns to mouth, esophagus and stomach. Also causes nausea, vomiting, diarrhea, etc.

Skin contact. Can cause burns and ulceration.

Eye contact: Even brief contact can cause severe damage.

Chronic Exposure: Unknown

Aggravation of preexisting conditions: Will aggravate preexisting skin conditions.
